1. Sealed tenders/quotations are invited from reputed Interior Decorators/ Contractors/ Carpenters for undertaking Internal Decoration/ Renovation of the Show room making of storage racks, sales counter, show case, ceiling ,wall paneling , signboard, electrical fittings etc work of Barpali Sale Branch of the society.
2. The works shall have to be executed within one month after placing orders, and only those tenderers who have the necessary expertise to execute the job within the stipulated time should submit the tenders on the above address. He shall have to pay 10,000/- (Rupees Ten thousand) only per day for any delay made for completion of the work after the stipulated period.
3. In case any portion of work is not completed as per laid down specifications and handed over the show room to the authority before the due date, penalty up to 5% on the total value of work allotted/awarded will be imposed per day by the undersigned.
4. The volume and number of works may vary as discretion of the undersigned, up to 40% of the contracted work either way & final payment to the contractor shall be regulated on the basis of actual work executed and on the rate(s) initially approved. For extra fittings contractor will have to quote rate separately. For all such extra fittings, the undersigned reserves the right to pay the lowest of the rates quoted by the competing Contractor.
5. The Contractor will be responsible for up keep and maintenance of the entire work done by him till the closing of the renovation work, for which, no extra payments shall be made. He shall therefore, have to ensure adequate number of carpenters/helpers to the satisfaction of the undersigned. Breakages and damages in any work shall immediately be settled and no extra payment will be made for any damage, breakage or loss on account of any reason or natural calamities. Lay out plans etc of the site shall have to be provided by the tenderers. 7. In regard to electrical fittings etc, the contractor shall have to engage qualified licensed Electrician/Contractor entitled to erect, handle and maintain high tension supply line and its up keep and maintenance.

8. The contractor shall not use any materials other than those specified in tender without the prior permission of the Managing Director, Sambalpur Bastralaya Handloom Cooperative Society Ltd, Bargarh.

9. No advance shall be paid to the contractor till completion of the work and handing over to the Authorities, but part payment may be considered to the contractor during the time of execution of work on mutual agreed upon between the contractor and the Authority. Final payments will be made only after completion of the interior/ renovation work and handing over the complex to the concerned branch in-charges.

Over writings in rate is not permitted. All corrections should be attested by the tenderers with his initials as many times as corrections occur. Each page of the Tender Form and other related papers submitted there- with should be signed by the tenderers. Any discrepancy in the rates written in figures and words, then the rates written in word is final. Similarly discrepancy in the rates quoted for unit rate and total amount, then the rate quoted for unit is final.

11. The tenderers are required to deposit an earnest/security money of Rs.10,000.00 (Rupees Ten thousand) only. The amount of earnest/security money will be accepted only in the form of Cash/ Cheque/Demand Draft/Bankers Cheque drawn in favour of the Sambalpur Bastralaya Handloom Cooperative Society Ltd, Bargarh.
